23/184 APOLOGIES

There were apologies from Cllr Tracy Sinclair. There were no declarations of interests.

23/185 MINUTES OF THE MEETING HELD ON 6 DECEMBER 2023

23/186 PUBLIC OPEN FORUM

Matters discussed were the building plot on South Back Lane, footway outside the village hall and the fence damaged at the village hall by a vehicle.

23/187 NORTH YORKSHIRE COUNCILLOR REPORT

Cllr Taylor had reported that the horse and rider signs at the Mill bend had now been installed. The issue regarding the uneven land outside the school was ongoing. The cancellation of HS2 northern section would result in NYC receiving some monies. The budget would be set next month and the last equalisation payment would be levied in April.

23/188 CLERK'S REPORT

- a. No more information has been received regarding the application to register Turvey's Triangle.
- b. No response had been received from NYC Highways regarding lorry restrictions in the village.
- c. The additional streetlamp outside the village hall from NYC was awaited.
- d. The replacement of 20 kerbstones near the shop by NYC was ongoing.
- e. Data had been collected from the two deployed VASS Signs. Contact would be made with Easingwold Town Council regarding the use of the software.
- f. The gully cleaning reported to NYC had been done apart from the odd gully where cars had been parked.
- g. The wayleave agreement with Northern Powergrid had been updated with the Clerk's details.
- h. The ownership of the path around the village green was still to be established.

The demolition of a barn on North Back Lane was noted. This apparently for safety reasons. The Clerk would ask NYC to inform the Council in the future as no notification was received.
