**25/33 APOLOGIES**

**25/35 PUBLIC OPEN FORUM**

Items discussed were the rat infestation, potholes and parking on the village green.

**25/36 NORTH YORKSHIRE COUNCILLOR REPORT**

Cllr Taylor had reported that the rat infestation was being investigated by NYC Environmental Health.

**25/37 CLERK'S REPORT**
